Richmond Upon Thames DM Polices DPD - DPR1 Gideon Amos and Reasonable Adjustment to Rechargeable Work

- 1. Gideon Amos (an IPC Commissioner) has now completed his examination of the above DPD. This was his first experience of the local plan examination process and associated hearing sessions and represented a significant learning curve. As such it was agreed at the outset of this Commissioners pilot that some adjustment may be necessary to the amount rechargeable to the LPA. This was on the basis that the LPA should not be burdened with a 'training' charge for the additional time a Commissioner might need to become familiar with the process. The LPA was also given an assurance that we would charge based on adjusted time/indicative allocation to ensure they were not unfairly penalised for being party to the pilot.
- 2. The Commissioner is not on the MWR system so the key record of time spent on the plan is set out on the DPR1. We consider that, to bring this into line with a typical allocation against a case such as this (whilst noting the Gideon did have to hold two rounds of hearing sessions), the initial examination/prep should be reduced to 15.1 days (from 23.4). We would also not normally sanction 4 days of site visits for a development management DPD and the associated 1.5 days of travel time. As such we have apportioned a nominal 0.5 days for site visit and travel, deducting the other 5 days and associated T&S costs of £507.35.
- 3. This means that whilst the DPR1 timings would point to an overall charge of £50,900.49, this is reduced by £14,248.34 to £36,652.15, which we consider a reasonable charge for this work taking into account all the particular circumstances of this DPD examination.
