YOUR REQUEST FOR INFORMATION

I am sorry about the delay in replying to your e-mail of 11th January 2010 in which you request information concerning internal reviews of Freedom of Information requests received at IPCC since the Act became effective in 2005.

You ask for the numbers of FOI requests received at IPCC during each of the five calendar years from 2005 -2009. The numbers received are as follows:

2005 - 572

2006 - 252

2007 - 202

2008 - 224

2009 - 234

You also request all data, if held, as to the number of internal reviews that have been rejected or upheld (even partially) by the IPCC in the same years.

No data has been compiled for the period from 1st January 2005 to 31st April 2009 and the IPCC holds only limited data as to the number of appeals received since 1st May 2009 and their outcomes. Such data as is available suggests that between 1st May 2009 and 14th May 2010, the IPCC received 20 requests for internal review of which seven were upheld either partially or wholly, ten were not upheld at all and three have yet to be decided. However, it is highly likely that these figures do not include all the requests for internal reviews received during the past year.

As the IPCC does not systematically record data relating to the FOI internal review requests it receives, the information you have requested can be obtained only by means of a manual search of each of the Commission's hard copy FOI files. As confirmed above, in the 5 years to 31st December 2009 the IPCC received 1484 FOI requests. I estimate that it would take in excess of 3 minutes to identify extract and collate the relevant data from each file so that producing the figures you require would exceed the cost limit under section 12 of the Freedom of Information Act, which limit is set in Regulations at £450 or 18 hours work at £25 per hour. Accordingly, I find that the IPCC is not obliged to answer this aspect of your request.
