I write further to your request for information received 25/01/2021.

How many Leicestershire Police officers were arrested between 2018 and 2021.

What rank were they, what offence were they arrested for and what was the outcome criminally and internally.

Including special constables and PCSOs.

Following receipt of your request, searches were conducted within Leicestershire Police to locate information relevant to your request.

Your request for information has now been considered and the information asked for is as follows: -

Leicestershire Police have recorded the below numbers of Leicestershire Police Officers and Staff arrested in the time period 2018-2021:

- Officers (Consisting of the ranks PC and SPC) 8
- Staff (Consisting of Staff and PCSOs) 6

Offences include:

- Acquire/Use/Possess Criminal Property & Money Laundering
- Breach of the Peace/Public Order
- Fraud/Theft/Fraud by Misrepresentation/Making an indecent photograph of a child
- Harassment
- Malicious Communications
- Misconduct in a Public Office
- Sexual Offence(s)
- Violence Against the Person
- Computer Misuse

Criminal Outcomes include:

- Adult Community Resolution
- Bind over for 6 months and £50 Fine/Conditional Discharge & Surcharge to fund Victim Service of £20 and to pay CPS costs £85

- Conditional Caution
- Discontinued
- Fined £230 & £115, Victim Surcharge £30, Costs £85, Restraining Order
- NFA
- Not Pursued
- Two years imprisonment, 12 month community order with 80 hours unpaid work. Costs of £485. Sex Offenders register for 5 years
- Still Live
