RE: Freedom of Information Act 2000 Request

I write in response to your Freedom of Information Act 2000 (or 'FoIA 2000') request dated 6 December 2019 which was later clarified on 16 December 2019. I note from your request that in relation to the 2017 Police SEARCH Recruit Assessment Centre you would like the mean scores achieved by different ethnic groups for the:

- Numerical reasoning test
- Verbal reasoning test
- Written test

You also request the sample size per ethnic group and the standard deviations.

Decision

After conducting careful searches for any information relevant to your request, I can confirm that there is information held in relation to your request. Please note that some of the numbers below may differ from those presented in the report which you refer to in your request, as when the original report was released it did not include data for December 2017. Where the number of candidates do not appear to add to the total number of candidates this is because either candidates or forces have not provided full data. Standard deviations provided are for these samples of candidates. With regards the written tests, please note that there are options for a force to choose from in terms of how they assess written communications, therefore the numbers of candidates in these categories are lower than the total number of candidates in a category. The actual number of candidates that we hold data for has been provided next to the mean scores in brackets.

Total number of candidates attending SEARCH in 2017 was 16860. The two tables below show the breakdown of candidates' ethnicity attending in 2017.
