**Subject: Proposed Badger Cull****

Dear all,

You may, or may not be aware that Derbyshire has again been proposed as a potential participant in a badger cull. This is subject to a last minute decision by the National powers that be, and may not actually happen, as was the case last year.

This Force is currently involved in planning for the eventuality that the cull will take place, and liaison between various agencies is underway.

The subject matter is highly controversial and there are strong, diametrically opposed views on both sides. The fact that Derbyshire may be a selected County, is of course to be kept closely guarded, with a need to know sanction in force. That said, it is becoming increasingly obvious that this proposal is well and truly in the public domain. I can evidence this by several enquiries to this office regarding grants of firearms, variations of currently held firearms and requests for open conditions. The reason cited is "for the badger cull".

The overall cull management I believe is being undertaken by either MAFF or DEFRA with involvement by the NFU and possibly other parties. It is certainly sanctioned by the Government in any event.

A cull company has been established which will provide training for potential “shooters”. We have no involvement or knowledge of what they are offering, the criteria for “shooter” or indeed the level of competence. Once a participant has passed this course, then I understand they will be “certified”

The purpose of this e-mail is to appraise you of the Regional Firearms licensing stance, and in particular, this departments response should you be asked.

Our overarching responsibility is public safety, and It is with this in mind that we issue the following guidelines. This is being reflected by our partner regional forces.

Firstly, the legislation regarding Badgers.

**Paragraph 14.60 of the Guide on Firearms Law states:**

The Protection of Badgers Act 1992 (as amended) makes it a criminal offence to wilfully kill, take or injure badgers except in limited circumstances (for example, as a mercy killing, as an incidental result of lawful action or **under a licence issued by the appropriate wildlife licensing agency**)

If badgers are to be killed by a firearm, this must be done with a smooth-bore weapon of not less than 20 bore or a rifle using ammunition having a muzzle energy of at least 160 foot pounds and a bullet weighing not less than 38 grains. This is in accordance with section 2(1D) of the 1992 Act.

One presumes that the cull company will have taken all measures to ensure that these criteria are met.

**Paragraph 10.51 of the Guide on Firearms Law states:**

A territorial condition restricts the areas where a firearm may be used by a person who holds a firearm for sporting purposes or for the shooting of problem wildlife. It is important that there should be standardisation of practice amongst forces and for this purpose it is recommended that new certificate holders should be limited to land considered suitable by the chief officer. **When the chief officer is satisfied that a certificate holder has gained sufficient competence with a particular calibre or class of firearm** the less restrictive condition may be considered appropriate ie open conditions. (see Appendix 3). In all circumstances the “any lawful quarry condition” should be applied (see Appendix 3).



Clearly, the ALQ condition only exists regarding badgers as long as the special licence remains in force. Any person applying for a grant of a firearm, a variation of a firearm or a request for open conditions cannot rely on the badger cull as their “good reason” as, when the licence is withdrawn, this “good reason” will cease to exist.

I hope you are well.

I understand that it is looking increasingly likely that a badger cull will come to Derbyshire later this year. As you would expect myself and the Derbyshire Wildlife Trust will be deeply frustrated and upset by this given the huge amount of work we have put into badger vaccination which is a real alternative to the cull. Also all the evidence indicates that there is not a significant reservoir of bovine TB in badger from the roadkill studies carried out by Nottingham University.

I am deeply concerned that the cull will seriously impact on our badger vaccination programme and pose significant risks for our volunteers who work with us in the field on all aspects of the badger vaccination project.

I would like to have the opportunity to talk to you about our concerns about the cull and the impact and risks it poses for our vaccination project. Also I would like to offer you the chance to come and see our badger vaccination project at first hand out in the field this summer. If you we tried to get you out to see badger vaccination taking place last year but it proved difficult to find dates and a location that suited you.

An open letter to Derbyshire Police and Crime Commissioner

Dear Hardyal Dhindsa - Derbyshire Police and Crime Commissioner,

We are writing to you with our concerns regarding the Derbyshire Badger Cull.

You previously publicly expressed that you are aware of the strong opposition to badger culling that your constituents hold. We therefore ask you to respond to the proposals to manage the delivery of both badger vaccination and culling in edge counties by 26 June 2020:

You have been quoted saying, "it doesn't make sense to pursue an expensive culling programme at the cost of the taxpayer". However, Derbyshire Constabulary incurred £35,737 police costs in 2019, despite the cull being cancelled. It is likely these costs will increase with 'Operation Freddo' (operating under the National Operation Cobb) policing the badger cull in the near future.

We are sure you are aware, that in the past, in other counties, patrol groups of protestors and those opposed to the cull have formed and have gone out into the countryside, day and night with the aim of protecting badgers. It is inevitable that opposing groups with very strong opinion may come across one another when tensions are high. It should be a concern that one of these groups will be carrying high powered firearms.

Derbyshire is unique as its badger vaccination programme is the biggest in the UK. The judgement of the judicial review, published last month, ruled it was legal to cancel the cull last year. It was highlighted that there would be public outcry if a vaccinated badger was killed.

The current proposal will not effectively stop a vaccinated badger from been culled. The no-cull buffers will be difficult to enforce. The current suggested buffer will likely allow culling on some parts of a property while forbidding it on others. In practice, this will be difficult to enforce when cull teams work at night and on private land.

An added challenge will be that vaccination licensees will not be told whether they are adjacent to cull land, and, hence, will presumably not know whether no-cull buffers are in place and whether to report suspected breaches to Natural England.

If a badger is harmed in a no-cull buffer it would be presumably a breach of licence and therefore an offence under the 1992 Badger Protection Act. This could be difficult to police and DEFRA has offered no guidance on how to police this situation.

We are appealing to you to please ask the Government, once again, to reconsider their plans when extending the badger cull to Derbyshire. If the cull does happen in Derbyshire, there needs to be legally enforceable no-cull buffer zones to protect vaccinated badgers.

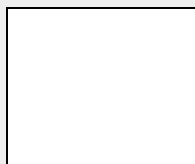

It was noted that the government can only give out 14 licences across the country to cull badgers so it's not officially going to happen yet until the announcement but if Derbyshire gets granted a licence, it will likely be valid from September. Tim mentioned that the Police may already know, however Hardy was unaware.

You may have heard that the Environment Secretary Theresa Villiers is not allowing the cull to come to Derbyshire which is a fantastic result. That also means you and your colleagues will not have to use valuable police resources on policing a cull. We have had a great response from members of the public who have written to their MPs across the county asking them not to support a cull coming to Derbyshire and to support our vaccination programme. Nigel Evans the Conservative MP for Ambergate now supports vaccination. Patrick McCloughlin is coming out to see our vaccination at first hand soon. Ruth George has also been extremely supportive of vaccination as well as Toby Perkins.

We may well have to do this all again next year but for now Derbyshire's badgers are safe.

New information has come out today about distressing welfare issues around shooting badgers as well as new evidence showing the cull is not reducing bovine TB in cattle. See this link:

It appears two local MPs (Pauline Latham and Heather Wheeler, who are pro-cull), have sent out an email with an attachment containing an official presentation to members of the public which itself contained the map for the Derbyshire Cull zone. I am currently seeking to establish the exact details, but the end result is the map is well and truly in the public domain. The anti-cull groups have obviously picked up it very quickly.

I would assess the actual operational impact as limited, as the approximate cull zone boundaries could be worked out reasonably easily and indeed the protest community have been operating in them all ready. However this will undoubtedly raise interest and likely media comment in the cull again. It certainly will concern the NFU and DEFRA so there will be some political ramifications. The

PCC may well be approached for comment as Derbyshire Against the cull have done that before, and Mr Dhindsa has provided one previously this year, voicing an opinion against the cull.

I have set some actions in motion in relation to it, as below, and will keep you posted in case of any relevant developments. Our media team are aware.

Mr Dhindsa, A few years ago I had the opportunity to sit in a meeting where you discussed interfaces that you as the PCC and the Derbyshire Constabulary had i.e. police dog welfare, wildlife crime and support for those who had been arrested etc. I was impressed that you seemed to have read the entire selection of reports, that must have been 2 inches thick and were knowledgeable on the salient points on each of the agenda items. I was further impressed that you wrote to the DEFRA to voice your support for badger vaccination and raised concerns in implementing a badger cull in Derbyshire. I was proud that you were the PCC for Derbyshire. When the badger cull was announced in Derbyshire this year, I was confident that, should Derbyshire Constabulary be required to attend, the officers would carry out their duties in a professional and non-bias way, as that has always been my previous experience of dealing with the police. However, after 6 weeks of the cull I have to say that, unfortunately, my opinions of the police have now changed. XXXX Time and time again the same cull contractors vehicles were seen with licence plates that had either been obscured or altered. Some vehicles were without tax or MOT and therefore were uninsured and illegal. At all of these occurrences, there were police officers present who decided to look the other way or advised it was up to their own discretion as whether action was taken. As a law abiding citizen I was shocked to

see this type of behaviour and bias policing from a UK police force. Whenever I was pulled over by the police, my insurance, and tax details were checked and I am sure that, should I not have had a licence plate showing, further action would have been taken. As we have a further 3 years, at least, of the badger cull in Derbyshire I would welcome your thoughts on the above; what can be done to improve the reputation of Derbyshire Constabulary and ensure that there is not a repeat of this bias policing style next year.
