<p>I would like to make a request for information under the Freedom of Information Act (2000).</p> <p>I would like to request information on the amount of reported dog thefts that you have received within the area of Portsmouth & Southampton.</p> <p>Could I please receive the amount of reported dog thefts:</p> <p>Over the past 5 years, broken down by each year (2015 - 2020) Each year of thefts to be broken down by specific breed of dog</p>	<p>Hampshire Constabulary does not hold this information in a retrievable format. The cost of determining if the information is held, locating and retrieving the information exceeds the 'appropriate level' as stated in the Freedom of Information (Fees and Appropriate Limit) Regulations 2004. It is estimated that it would cost more than £450 to comply with your request.</p> <p>Hampshire Constabulary records crime in accordance with the Home Office Counting Rules. Dog theft does not have a specific Home Office crime classification. To accurately determine the number of dogs that have been reported stolen for the date period in question, a manual review of every theft and burglary recorded on the force Records Management System for the area specified, would have to be</p>

There are thousands of theft and burglary offences for the time period specified and to review each one would exceed the 18 hour time limit set by the FOI regulations.</p> <p>In accordance with the Freedom of Information Act 2000, if one element of a request exceeds the statutory cost limit, the whole request may be refused on grounds of cost. As such, this letter acts as a Refusal Notice in respect of your whole request.</p>
