### **Freedom of Information Request – FOI2019/00176**

I am writing in response to your email received by Post Office Limited ("Post Office") on 08 April 2019, which I am dealing with under the terms of the Freedom of Information Act 2000 ("FOIA").

In your email you have requested information in six parts:

*Could you please provide me with the latest set of figures for the following questions:*

*a) The total number of Post Office Outlets in Scotland*

I can confirm that Post Office does hold the information you requested, there were 1382 open and trading Post Office in Scotland at the end of February 2019. The remainder of your questions (b-e below) are based on the same point in time for the Government Region of Scotland's open and trading branches.

*b) The total number of Post Office Outlets in Scotland that are classed as 'Outreach'*

There were 229 outreach branches.

*c) The total number of Post Office Outlets in Scotland that are classed as 'Satellite'*

There was one Satellite branch.

*d) The total number of Post Office Outlets classed as a 'Mains' branch.*

There were 278 Mains branches.

*e) The total number of Post Office Outlets classed as a 'Local' branch*

There were 206 Local branches.

*f) The total remuneration for Agents/Subpostmasters/Operators in Scotland*

The total remuneration for Scotland branches from April 2018 to March 2019 was £28.3m.

I hope the information I have provided on this occasion is useful, however if you are dissatisfied with the handling of this response, you do have a right to request an internal review. You can do this by writing to the address below stating your reasons for your internal review request.
