Re: Your request to the IPCC - Freedom of Information Act 2000 (FOIA)

Thank you for your email of 15 September 2015 in which you make a request under the FOIA.

Your request is as follows:

I would like to ask for all the supporting evidence that led one of your people, namely Lisa Parris Lester to reach the decision she did to support corrupt police officers at South Wales Police. She has told me herself that it is not a subject access data request but an FOI request and then I told her she is completely wrong to state that but I will now submit this request through FOI channels. This really sums up the incompetence of people who work for you that they do not even know basic common sense but stubbornly refuse to listen to us, the public, who know better.
