

The Fenland Local Plan (2014) sets out that development of an urban extension (i.e. the broad or specific locations for growth identified in Policies LP8-11 of the development plan) must be planned and implemented in a coordinated way, through an agreed overarching broad concept plan, that is linked to

the timely delivery of key infrastructure. With the exception of inconsequential very minor development, proposals for development within the identified growth locations which come forward prior to an agreed broad concept plan being produced will be refused.

Fenland DC are preparing such a Broad Concept Plan with supporting text for East Chatteris. At present, the program is that this document will be subject to 2 public consultation events in Chatteris on the 20th and 21st July (an earlier draft has already been presented to Chatteris Town Council). Following that, depending on comments received, the scheme will be amended with a view to it being presented to Planning Committee probably in October this year.

Fenland DC have approached CCC for early comments as this version this is not the final version that Planning Committee will consider.

Whilst the Broad Concept Plan focuses on setting out the basic framework for the site, CCC need to raise infrastructure and service requirements which may have land or site requirements needed for successful implementation, e.g. LLL or social services. A fairly high level response flagging these issues for addressing through the planning application would be appropriate.

The Broad Concept Plan should be address the criteria set out in Local Plan Policy LP7 which includes the following items which will be of interest to the County Council:







#### 1.0 Site Description

- 1.1 This 25 hectare proposed development area lies at the south eastern end of Chatteris town, on a former fen island approximately 9 miles to the south of March where the heavy clay soils of low-lying fields (c. 5mAOD) are located on Ampthill Clay substrate. The western boundary of the development area coincides with that of the glacially deposited March Gravels, where they protect the underlying clay forming a north-south linear spine of higher land rising to 10mOD.
- 1.2 Aerially, the heavy clay soils are notoriously silent in archaeological terms in that they do not tend to yield cropmarked evidence of archaeological activity, in contrast, for instance, with highly visible late prehistoric and Roman evidence (eg MCB11284) based on river terrace deposits at Langwood Fen 1.5km to the south east. Consequently little is known of land uses and activity that predates the medieval open fields, for which abundant evidence in known in ridge and furrow form from within and surrounding the development area (eg CHER ref 10534). Additionally, a single, undated circular enclosure is known from within the development area (MCB11292). Prehistoric flints are known from the southern perimeter of the site while fieldwalking in advance of the construction of the by-pass in the 1980s (MCB10535), as were 14<sup>th</sup>-17<sup>th</sup> century sherds of pottery along with the foundations of a substantial building (MCB10533). Excavations at Cromwell Community College demonstrated the presence of Iron Age settlement features (MCB19835), while Bronze Age and Saxon occupation evidence was also present in land investigated at Tithe Barn Farm (MCBs 12808-9). The by-pass conjoins Ireton's Way on the south side of town, next to the proposed development area. Formerly a toll road, it was built under the orders of General Ireton during the Civil War to ease troop movements between Chatteris and Ely.
- 1.3 The Wenny area of town refers to the name of the medieval fen meadow of which there were many at the perimeter of the medieval core settlement. It lies to the immediate south east of the location of an early 12<sup>th</sup> century Benedictine nunnery of which only traces of stray masonry now survive. About half of the development area is currently registered as a Park and Garden. Created in the 19<sup>th</sup> century, it forms part of the landscaping of an earlier house established in the late 18<sup>th</sup> century, for Manor House (MCB14171) and its associated outbuildings, all of which are listed.

- 1.4 Within the site, the cultivation ridge and furrow remains survive as very clear earthworks in the majority of the large central parkland field (MCBs 10534 & 11717 see attached Flash Earth image). These remains are also clear in the geophysical survey recently conducted for this site (Stratascan 2015 *Wenny Road, Chatteris Cambridgeshire. J7854.* SCB46603). Archaeological earthworks are rare in Cambridgeshire and, where they survive well they require preserving in situ. For Wenny Road, heritage policies in Fenland Local Plan section 4.5.5 and Policy LP10 Chatteris apply.
- 1.5 Detailed archaeological evidence and references for these and other sites is contained in the HER search attached to this brief. Please complete and return the licence attached to the search data provided with this brief to obtain the (free) GIS files from the HER. Reproduction of spatial data by any other means is not recommended.

#### 2.0 The nature of the development and archaeological requirements

- 2.1 The development is for 300+ houses, with associated infrastructure.
- 2.2 Due to the high archaeological potential of the site the applicant is advised to provide information concerning the potential impact of the proposal on archaeological remains. In order to provide this information an archaeological evaluation of the site is necessary. This design brief sets out the requirements for the adequate archaeological evaluation of the site.
- 2.3 The evaluation should include a suitable level of documentary research, including further consultation with information held in the CHER as necessary, to set the results in their geographical, topographical, archaeological and historical context.
- 2.4 The required scheme shall include a field evaluation of the application area.
- 2.5 The characterisation of the artefact contents of the ploughsoil and any lower soil horizons should be attempted, to provide an understanding of the presence/absence and condition of underlying archaeological remains. Bucket sampling of separate soil horizons (90 litre samples) at each end of the evaluation trenches should adequately test the soils across the site.
- 2.6 The evaluation should include a programme of linear trial trenching (or test-pitting in confined areas) to adequately sample the threatened available area and will excavate sufficient archaeological features to conform to section 3.0 below.
- 2.7 The use of metal detectors on site to aid the recovery of artefacts is required. The detector should not be set to discriminate against iron. A plan of detected items should be submitted to HET in advance of the location of trenches.
- 2.8 <u>All</u> features must be investigated and recorded unless otherwise agreed with HET. Investigation slots through all linear features must be at least 1m in width. Discrete features must be half-sectioned or excavated in quadrants where they are large or found to be deep. The use of boreholes is recommended to gain information from very deep deposits.
- 2.9 The evaluation results will be used to determine the need, design and extent of any mitigation works that may be required.
- 2.10 The mitigation of construction impacts to archaeological remains that are identified during this evaluation will be outlined in a further Design Brief.

#### 3.0 Objectives

3.1 The evaluation should aim to determine, the location, extent, date, character, condition, significance and quality of any surviving archaeological remains liable to be threatened by the proposed development. An adequate representative sample of all areas where archaeological remains are potentially threatened should be studied. This office will be particularly

concerned with the amount of truncation to buried deposits, the presence or absence of a palaeosol or 'B' horizon, the preservation of deposits within negative features, site formation processes generally. To these ends buried soils and associated deposits should be inspected on site by a suitably qualified soil scientist and his/her advice sought on the whether soil micromorphological study or other analytical techniques will enhance understanding of the site. If so, suitable samples should be taken from relevant deposits/features and assessed.

- 3.2 Specialist advice concluded that aerial photographic survey & transcription is not recommended for this site
- 3.3 A geophysical survey has been conducted (SCB 46603) A digital copy of the geophysical survey evidence should be supplied with the report for inclusion in the CHER.
- 3.4 An earthwork survey is required to map the cultivation remains evident in the pasture fields of the application area. See EH 2009 (2<sup>nd</sup> ed) *Metric Survey Specifications for Cultural Heritage* section 6 for guidance on earthwork recording procedures. The survey should be sent to HET prior to the commencement of trenching. Areas in which well-preserved ridge and furrow or headland earthworks are present should NOT be subject to trenching.
- 3.4 The assessment of the environmental potential of the site through examination of suitable deposits must also be arranged with a suitably qualified specialist. Attention should be paid:
  - to the retrieval of charred plant macrofossils and land molluscs from former dry-land palaeosols and cut features, and to soil pollen analysis;
  - to the retrieval of plant macrofossils, insect, molluscs and pollen from waterlogged deposits located.
  - provision for the absolute dating of critical contacts should be made: *eg* the basal contacts of peats over former dryland surfaces; distinct landuse or landmark change in urban contexts

The assessment of environmental potential should consider the guidelines set out in the following documents:

The Project Manager is also advised to consult the following guidance documents in order to provide an adequate strategy for the excavation, field treatment and conservation of any delicate organic materials: English Heritage, 2012, Waterlogged Organic Artefacts: Guidelines on Their Recovery, Analysis and Conservation; English Heritage, 2008, Investigative Conservation: Guidance on How the Detailed Examination of Artefacts from Archaeological Sites Can Shed Light on Their Manufacture and Use; English Heritage, 2010, Waterlogged Wood: Guidelines on the Recovery, Sampling, Conservation and Curation of Waterlogged Wood.

The project manager must ensure that the results of palaeoenvironmental investigation or industrial residue assessments/analyses are included in a full report and sent to the English Heritage Science Advisor.

3.5 The evaluation should also carefully consider any artefact or economic information, in particular the survival of faunal evidence, and provide an assessment of the viability for further study of such information. It will be particularly important to provide an indication of the relative importance of such material for any subsequent decision-making regarding mitigation strategies. Advice is to be sought from a suitably qualified specialist in Faunal Remains on the potential of sites for producing bones of fish and small mammals. If there is

- potential, a sieving programme is to be undertaken. Faunal remains collected by hand and sieving are to be assessed and analysed if appropriate.
- 3.6 The evaluation should include a comprehensive, illustrated assessment of the regional context within which the archaeological evidence rests and should aim to highlight any relevant research issues within a national and regional research framework.
- 3.7 The evaluation should provide a predictive model of surviving archaeological remains detailing zones of relative importance against known development proposals. An impact assessment should also be provided.
- 3.8 If any of these areas of analysis are not considered appropriate the report will detail justification for their exclusion.

#### 4.0 Requirements

- 4.1 The evaluation must be undertaken by an archaeological team of recognised competence, fully experienced in work of this character and formally acknowledged by the HET officers, advisors to the Local Planning Authority (LPA). Inclusion in The Institute for Archaeologists' Register of Archaeological Organisations is recommended. Details, including the name, qualifications and experience, of the site director and all other key project personnel (including specialist staff) will be communicated to HET as part of a specification of works to be submitted by the archaeological contractor undertaking the programme. The specification must conform to the guidance in English Heritage's MoRPHE publication (Management of Research Projects in the Historic Environment. The MoRPHE Project Manager's Guide. EH 2006). This specification must:
  - 1. be supported by a research design which sets out the site specific objectives of the archaeological works.
  - 2. detail the proposed works as precisely as is reasonably possible, indicating clearly on plan their location and extent.
  - 3. provide a timetable for the proposed works including a "safety" margin in the event of bad weather or any other unforeseen circumstances that may effect this timetabling.
- 4.2 Care must be taken in the siting of offices and other support structures in order to minimise impact on the environment. Extreme care must also be taken in the structure and maintenance of spoil heaps for the same reasons and to facilitate a high quality reinstatement. This is particularly important in relation to pastureland.
- 4.3 The archaeological project manager must satisfy themselves that all constraints to groundworks have been identified, including the siting of live services, Tree Preservation Orders and public footpaths. The HET officers bear no responsibility for the inclusion or exclusion of such information within this brief.
- 4.4 Care must be taken in dealing with human remains and the appropriate guidance issued by the Ministry of Justice should be followed. Environmental health regulations must also be followed. The Cambridgeshire Historic Environment Team and the local Coroner must be informed immediately upon discovery of human remains. If found during an evaluation, the human remains must be left *in situ*, covered and protected when discovered. No further investigation should normally be permitted beyond that necessary to establish the date, condition and character of the burial. - 4.6 Before commencing work the project manager must carry out a risk assessment and liase with the site owner, client and HET in ensuring that all potential risks are minimised. A copy of this must be given to HET before the commencement of works.
- 4.7 Project Managers are reminded of the need to comply with the requirements of the Treasure Act 1996 (with subsequent amendments). Advice and guidance on compliance with Treasure Act issues can be obtained from the Cambridgeshire Historic Environment Team (CHET) office. Any finds that could be considered treasure under the terms of the Act made during the process of fieldwork should be **immediately** reported to the Finds Liaison Officer of the Portable Antiquities Scheme based in CHET, so that it is reported to the appropriate Coroner within 14 days of discovery in line with the Act<sup>1</sup>.
- 4.8 The site archive specification should conform to the guidelines in MoRPHE (EH 2006), eg section 2.5.3 and be deposited within the County's archaeological archive storage facility on completion of site analysis and any ensuing publication.
- 4.9 To assist with the curation of the project's archive, the Project Manager must contact the CHER office to obtain an **event number**. CHER will use this number as a unique identifier linking all physical and digital components of the archive. **The unique event number must be clearly indicated on any specification received for this project, on relevant ensuing reports and on the OASIS data collection form (see 4.11 below).**
- 4.10 Arrangements for the long term storage and deposition of all artefacts must be agreed with the landowner and CHER before the commencement of fieldwork. The Project Manager should consult *Deposition of archaeological archives in Cambridgeshire* (2014) regarding the requirements for the deposition of the archive into the archive storage facility on completion of the archaeological programme. - 4.11 Cambridgeshire County Council's Historic Environment Team supports the national programme: Online Access to the Index of Archaeological Investigations (OASIS III) project and requires archaeological contractors working in Cambridgeshire to support this initiative. In order that a record is made of all archaeological events within the county occurring through the planning system, the archaeological contractor is required to input details of this project online at the ADS internet site<sup>2</sup>: The OASIS reference ID and Data Collection Form should be clearly presented in the relevant report. Any report that does not contain this information will not be approved.
- 4.12 An unbound hard copy of the report, clearly marked **DRAFT**, should be prepared and presented to HET within four weeks of the completion of site works (unless there are reasonable grounds for more time). This report must conform to the format contained within the document **HET Eval rev 06** dealing with the production of archaeological evaluation reports. Copies can be obtained from the address below. CIfA *Standard and Guidance for Archaeological Field Evaluation* (2008) Annex 2, Report Contents, should be used.
- 4.13 Following acceptance, **one copy** of the approved report of the results should be submitted to the CHER. The approved report should also be uploaded to the OASIS database within **two weeks** of approval.
- 4.14 HET officers are responsible for monitoring all archaeological work within Cambridgeshire and will need to inspect site works at an appropriate time during the fieldwork, and review the

progress of excavation reports and/or archive preparation. Further trenching or deposit testing may be a requirement of the site monitoring visit if unclear archaeological remains or geomorphological features present difficulties of interpretation, or to assist with the formulation of a mitigation strategy. Appropriate provision should be made for this eventuality. The project manager must inform HET in writing **at least one week in advance** of the proposed start date for the project.

- 4.15 Any changes to the specifications that the project manager may wish to make after approval by this office should be communicated directly to HET for approval.
- 4.16 HET should be kept regularly informed about developments both during the site works and subsequent post-excavation work.
- 4.17 The involvement of HET should be acknowledged in any report or publication generated by this project.





- 1. A few single sherds found during fieldwalking on the route of the Chatteris by pass. Ridge and furrow in the field bounded by Wenny Road and Campole Drove.
- O1, Ridge and furrow seen from road is in good state of preservation as earthworks. Field bisected by by-pass has best preserved ridge and furrow on SE side.
- 2. On this AP (BK 93) more ridge and furrow in pasture can be seen surviving in adjoining field to W at TL/399-/856- and TL/398-/859-.
- 3. Brick footings excavated here probably formed part of a medieval-post medieval agricultural complex, possibly incorporating a stable or sheepfold. Pottery suggests this building was in use c. 1600. It cuts across ridge and furrow cultivation.
- 4. AP assessment along the route of the Chatteris to Haddenham water pipeline mapped the areas of medieval cultivation remains around Chatteris. Most of the features have been levelled by arable cultivation, with a few pasture fields retaining earthwork remains.
- 5. Ridge and furrow was identified during a geophysical survey in the south-western fields of the site. There is good survival of ridge and furrow in the field north of Wenny Road, West of Birch Fen Drove, centred 539890 285610, following the boundary alignment (NE-SW). The better preservation of Ridge and Furrow occurs in the western half of the field, and though still present in the eastern half, they are much reduced and lack integrity as earthworks in some parts of the field at this end.
- 6. Seen as cropmarks, the recreational ground West of The Elms, east of Wenny Road, 539720 285782, also has Ridge and Furrow following the boundary alignment (NE-SW).

#### Description

1. An archaeological excavation uncovered the rest of the Iron Age settlement identified in the evaluation (ECB3572). Up to 125 features were dated to the Early Iron Age. The extent of the settlement remained within the excavation area and was fairly short lived. It appears to have been established east of a boundary ditch with a possible entrance way. Within the settlement area there were several clusters of pits and post holes. To the south of the clusters there were two possible four-post structures arranged in a sub-square shape.

After the abandonment of the Iron Age settlement it appears the site remained in agricultural use until the present day, with evidence from Medieval/Post-Medieval ridge and furrow.

From the Iron Age pottery recovered, mainly from pits and post holes, there were four main fabric types; sandy, shell-tempered, chalk and flint which is similar to the results from the evaluation.

A small quantity of animal bone was recovered and two radiocarbon dates were taken from cow and sheep bone recovered from one of the pits. These produced a date range of mid 6th to 5th centuries BC (c.545-402BC). The feature also contained Early Iron Age pottery.
