## 2013/622 - Ched Evans

In response to your recent request for information regarding;

Copies of all emails between North Wales' Press Department and members of media both local and national to include print broadcasting and in particular but not confined to online journalist.

<u>Clarification Request:</u> Please would you clarify if you require emails regarding a particular topic, or all 'emails between North Wales' Press Department and members of media both local & national to include print broadcasting and in particular but not confined to online journalist'.

<u>Clarification Response:</u> I do apologise, all emails that make reference to Ched Evans, in particular but not confined to emails that were sent before to the trial to online journalist.

Please see below response.

The Freedom of Information Act requires that responses cannot disclose any information which will breach the Data Protection Act 1998. The information that you have requested is personal data of which you are not the subject (relating to a third party (section 40(2)) and the falls within paragraphs (a) to (d) of the definition of 'data' in Section 1(1) of the Data protection Act 1998 and disclosure of the information to a member of the public otherwise than under this act would contravene data protection principles.

Section 40 is a class based exemption, therefore it is not necessary to evidence harm caused by disclosure.

Therefore, in accordance with the Freedom of Information Act 2000, this letter acts as a Refusal Notice under section 17 (1) of the legislation, and any personal details have been redacted out of your response.



## Tweeting arrests update

North Wales Police have confirmed that the three individuals arrested as part of their investigation into the social media site naming of the victim in the Ched Evans rape case have been released on bail.

All three have been bailed following questioning at Sheffield Police Station to return to a Police station in North Wales in the near future. They have been bailed to allow Police to conduct further enquiries and to consult with the Crown Prosecution Service.

DCI Steve Williams leading the investigation added. "Further arrests are planned and will be made in the forthcoming days"
