Please can you assist me through the Freedom of Information in providing the following information please:

- 1. Please state the number of printers currently within the organization, including MFD's & photocopiers
- 2. What percentage of your fleet is in colour vs mono?
- 3. In terms of usage, what is your monthly page volumes?
- 4. Who are the main manufacturers for the printers (hardware)?
- 5. Who are the main supplier(s) of print consumables (Toner, spares, etc)?
- 6. What are the start and end dates for the print support contract(s) if applicable?
- 7. What is the approximate spend on printers and consumables during the last vear?
- 8. What is the length of the MFD contract(s)?
- 9. What are the start and end dates for the managed print contract in your organization (if applicable)?
- 10. Which procurement route or framework was used to procure this service?
- 11. The named person and their role in your organization is in charge of the procurement for printing and any managed print contracts.



Response:

- 1. There are currently 66 printers and 27 MFD's.
- 2. 100% MFD's are colour capable, 22.7% of printers are colour capable.
- Page volumes of printers are not recorded.
 For MFD's based upon usage throughout the financial year 2016/17 the average monthly usage volume was: 241.907
- 4. Printers numerous manufacturers, but mainly HP. MFD's Konica Minolta.
- 5. MFD's Konica Minolta. Printers unknown as purchased departmentally from numerous suppliers.
- 6. Not applicable.
- 7. Printers £1,408.98 since 26/09/2016 to date. Individual consumables are not identifiable from budget cost centres.
- 8. All are either 3 or 5 year agreements.
