Re: Internal review of Case ref: No. 950 and 1932 Conclusive evidence, the data to assess the putative flu vaccine / COVID-19 relationship and Proof that PHE research did cultivate and isolate the Covid19 virus

I refer to your emails of 4 September 2020 and 2 December 2020 requesting an internal review of the handling of case references 950 and 1932, respectively, in relation to your requests for information under the Freedom of information Act 2000 (FOI) "the Act".

Your Request case ref: 950

Public Health England (PHE) received your information request on the 04 August 2020.

Under the FOI Act PHE had until the 03 September 2020 to respond to your request or the 1 October 2020, if it extended the time for compliance by an additional 20 working days to allow more time to consider the public interest in disclosing or withholding the information specified, and tell you when to expect a response.

Case ref: 950 Response:

PHE sent you its response on the 14 November 2020 and, correctly, confirmed it did not hold the information you requested. PHE also provided you with advice and assistance under section 16¹ of the FOI Act by including the following link which provides details of flu vaccination uptake in various groups: https://www.gov.uk/government/statistics/annual-flu-reports.
