What departments are based at each location i.e. Headquarters, Neighbourhood Policing, Investigations. | <p>This request is being refused under Section 12(1) of the FOIA.</p> <p>Section 12 of the FOIA allows that public authorities do not have to comply with section 1(1) of the Act if the cost of complying would exceed the appropriate limit. In accordance with the Freedom of Information Act, this letter represents a Refusal Notice for this request.</p> <p>The information regarding which departments are based at each location is not held in an easily retrievable format. Most police buildings are multi-use buildings and may house members of a number of units and units may be spread over a number of buildings. Other members may be 'based' at a specific building for administration purposes but have a mobile role. We would have to cross reference each member of staff's role and 'base' station to</p> |
