Subject: PSNI Support of External Advertising Company

### Request and Answer:

Your request for information has now been considered. Under section 1 (1) of the Freedom of Information Act 2000 (FOIA) PSNI is under a twin duty when it receives a request, firstly to confirm if it holds recorded information in regard to your request and if so to provide it to you unless an exemption at Part 2 of the FOIA applies. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your requests relate.

You made the following requests to us:

"After the latest news that ASG & Partners (owned by Colin Anderson) have hired, and continue to hire a violent sexual offender who is also his son, Jeffrey Anderson, to work on advertising campaigns,

I would like to request the following information:

## Request 1

In the last 5 financial years how much has your organisation paid to ASG & Partners for services.

### **Answer**

The ScamwiseNI Partnership is one of the largest crime prevention partnerships in Northern Ireland, with over 40 members. The Police Service of Northern Ireland is just one of the partners involved and the information we hold which you have requested relates to information held about that partnership. The objective of the partnership is to raise awareness and to educate the public on the various types of scams and to ensure they are scam aware. To do this, the Partnership appointed an advertising agency through the appropriate procurement channels. The successful company was ASG & Partners.

The ScamwiseNI advertising budget has been received through ARCS/ARIS funding. ARIS is the Asset Recovery Incentivisation Scheme which is the distribution by the Home Office of money obtained through the Proceeds of Crime Act (POCA). The aim of ARIS is to improve the POCA regime and/or Increasing Effectiveness in Crime fighting/Crime Reduction.

ARCS is Assets Recovery Community Scheme fund, part of which is used to support projects that prevent crime or the fear of crime and is distributed by DoJ.

The Police Service of Northern Ireland administer the monies on behalf of the ScamwiseNI Partnership.

Breakdown of ScamwiseNI Spend is as follows:

ScamwiseNI total spend - £182,230.96

In addition to above, The Police Service of Northern Ireland appointed ASG & Partners through a separate procurement process to purchase/buy advertising space to promote the Christmas Domestic Abuse campaign in November 2017.

Police Service of Northern Ireland Total spend - £28,034.79

### Request 2

In light of the news articles below, will your organisation be reviewing your relationship with ASG & Partners?

#### **Answer**

It is the ScamwiseNI Partnership that have a contract with ASG & Partners and this will cease on 04 February 2021.

Is your organisation currently working with ASG on current/future advertising campaigns?

#### Answer

As above, it is the ScamwiseNI Partnership that have a contract with ASG & Partners and this will cease on the 04 February 2021.

You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
