

**PUBLIC PATH TEMPORARY STOPPING UP ORDER
TOWN AND COUNTRY PLANNING ACT 1990 - SECTION 257**

**THE PEAK DISTRICT NATIONAL PARK AUTHORITY
PUBLIC FOOTPATH NO 30 (PART) - PARISH OF GREAT LONGSTONE
PUBLIC PATH TEMPORARY DIVERSION ORDER 2019**

This Order is made by the Peak District National Park Authority ("the Authority") under section 257 of the Town and Country Planning Act 1990 because it is satisfied that it is necessary to temporarily stop up part of the footpath to which this order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990, to protect the safety of the public during mineral operations which are subject to conditions under the decision notice of Planning Permission No. NP/DDD/0815/0780.

BY THIS ORDER:

1. The footpath over the land situated at Watersaw Rake in the Parish of Great Longstone and shown by a bold black continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order ("the Schedule") shall be temporarily stopped up as provided below.
2. There shall be created to the reasonable satisfaction of the Peak District National Park Authority an alternative highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
3. The temporary stopping up of the footpath shall have effect on the date on which the order is confirmed and shall be effective for 5 years from that date or until the Authority certifies that the footpath has been reinstated satisfactorily following completion of the restoration works if that date is sooner.
4. The developer, British Fluorspar Ltd, Cavendish Mill, Farnsley Lane, Stoney Middleton, Hope Valley, Derbyshire, S32, 4TH is hereby required to pay the full costs of seeking the temporary stopping up Order and it or its successor

in title shall be responsible for restoring the footpath upon its original alignment to a condition suitable for public use.

5. Where immediately before the date on which the footpath is temporarily stopped up, there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying out their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY TO BE TEMPORARILY DIVERTED

Length A-B

The whole width of that part of Public Footpath No. 30 Parish of Great Longstone shown by a bold continuous line on the Order Map commencing at point A at Ordnance Survey grid reference SK 1890 7326, running in an easterly, northerly and east north easterly direction to point B at Ordnance Survey grid reference SK 1925 7336 - a length of approximately 390 metres.

PART 2

DESCRIPTION OF SITE OF ALTERNATIVE FOOTPATH

Length A-C-B

A naturally surfaced public footpath 2 metres in width shown by the dashed line on the Order Map commencing at point A at Ordnance Survey grid reference SK 1890 7326, running in a north easterly direction to point C at Ordnance Survey grid reference SK 1895 7326 and then in an east north easterly direction to point B at Ordnance Survey grid reference SK 1925 7336 - a length of approximately 370 metres.

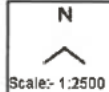
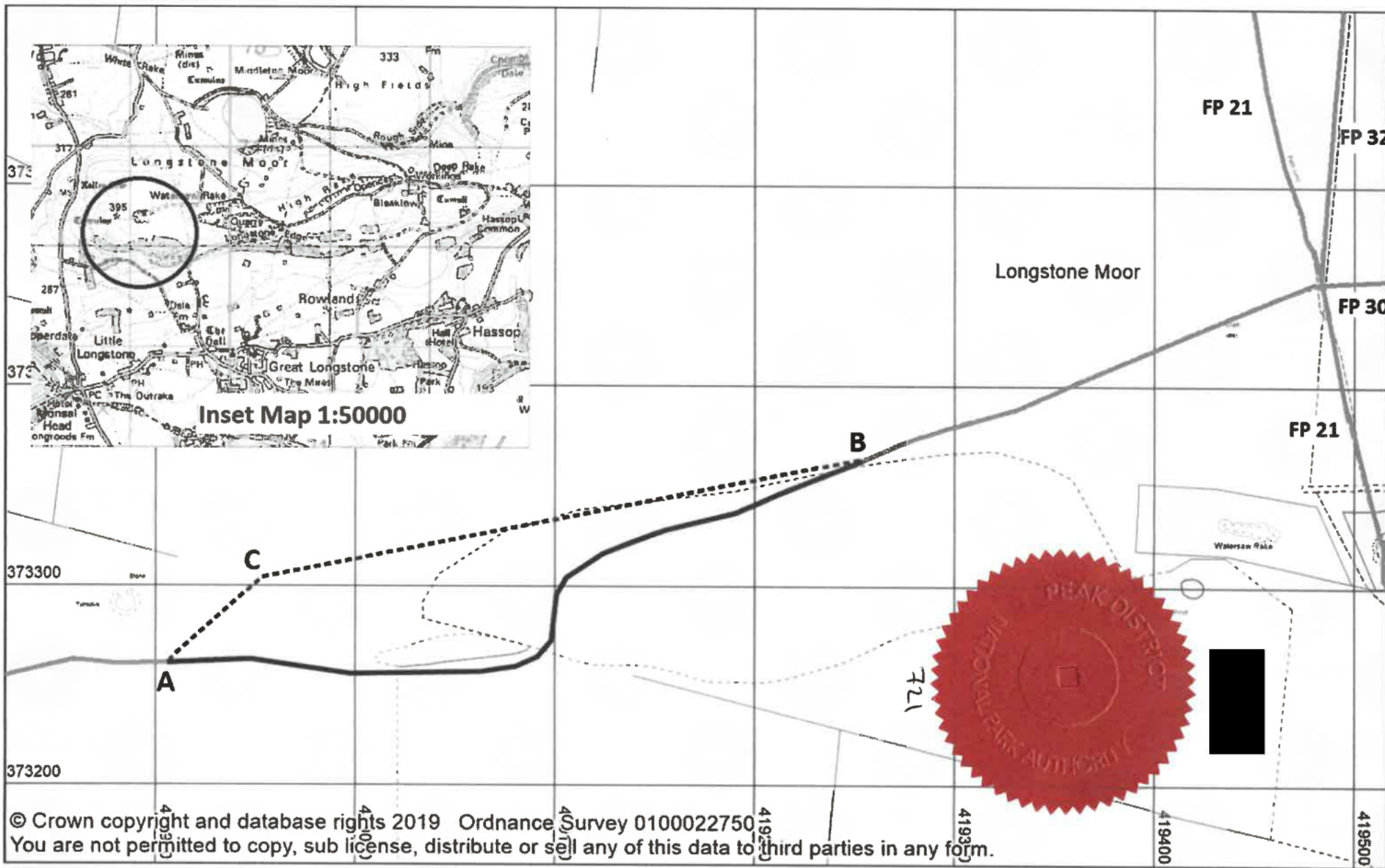
