Public Path Diversion Order Notices are advertised in accordance with the relevant statutory regulations which specify publication in at least one local newspaper circulating in the area in which the land is situated. This is usually the Oxford Times, but occasionally others e.g. Henley Standard. Orders are also advertised online on Oxfordshire County Council's consultation portal <a href="https://consultations.oxfordshire.gov.uk/consult.ti/system/listConsultations?type=O&s">https://consultations.oxfordshire.gov.uk/consult.ti/system/listConsultations?type=O&s</a> ort=ca\_opendate&dir=desc as well as on site and at named deposit addresses.

Public Notices for Traffic Regulation Orders are published in at least one local newspaper circulating in the local area. Often this will be the Oxford Times but depending on the location of the proposal from time to time we have also used the Oxford Mail, Herald Series, Henley Standard, Swindon Advertiser, Bicester Advertiser, Banbury Guardian, Thame Gazette, Reading Post, Witney Gazette. Proposals which are likely to affect a large number of people (such as the increase in charges for Residents Parking Permits) are also published on the Council's website.
