Freedom of Information Request 17/06/657

I write in response to your request for information under the Freedom of Information Act 2000 (FOIA) received on 23 June 2016:

I would like to request data on instances of Public Order Offences for each day for your region for the period 1 January 2014 to 31 July 2016 inclusive, broken down by alcohol related and nonalcohol related offences.

The number of public order offences recorded by Kent Police can be found within the attached appendix. Please note that the figures are based on the Public Order Offence category contained within the Home Office Counting Rules for Recorded Crime (please see: https://www.gov.uk/government/uploads/system/uploads/attachment_data/file/602809/count-public-order-apr-2017.pdf). Please ensure you read the information warnings (in red) in conjunction with the results.

Unfortunately whilst there is a flag which is available for manual input onto a crime in order to highlight whether alcohol is likely to have contributed to the offence, this flag, which is known as an MO code, is infrequently used. As such, there are only nine crimes with the marker added during the specified period. In order to determine the true number of offences which have involved alcohol we would need to manually review each crime. Such a task would greatly exceed 18 hours of work. Your request therefore engages an exemption at Section 12(1) FOIA.

Section 12 provides an exemption from a public authority's obligation to comply with a request for information where the cost of compliance is estimated to exceed the appropriate limit. The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 state that the appropriate cost limit is 18 hours in the case of the Police Service.

To assist you we have been able to provide the total number of public order offences recorded together with details of the nine which do have the alcohol MO code added to them (please see the information warnings within the appendix).

I apologise that this response is reaching you outside of the Act but I thank you for your interest in Kent Police. If you have any queries about your request or the application of the FOIA generally, please contact this office quoting the reference number above.

Your right to appeal

We take our responsibilities under the Freedom of Information Act seriously but, if you feel your request has not been properly handled or you are otherwise dissatisfied with the outcome of your request, you have the right to appeal.
