FOI Request – Purchasing accommodation for the homeless and 21 Wye Street SW11  
Review of Decision

I have been asked by the London Borough of Wandsworth to carry out a review of the request received on 11 December 2017 and the response of 15 February 2018.

Your request asked a number of questions relating to the purchase of accommodation for the homeless and several questions specifically in relation to 21 Wye Street SW11.

Responses were given to each question.

Your email of 24 February 2018 expressing dissatisfaction stated:

**You have acted unconscionably and failed to provide full disclosure to my request dated 11.12.2017**

- 1. Please provide the budget approved for each year for purchasing accommodation for housing the homeless**
- 2. Please provide the record with the number of homeless people accommodated by Wandsworth Council Officials at 21 Wye Street, London SW11 2SN, since 04.05.2016, as per the policy (paper) 14-317 and**
- 3. the annual budget approved by the executives of Wandsworth Council and**
- 4. their relationship to any of the Wandsworth Council's officials, agents**
- 5. Please provide the record of the names of homeless people accommodated by Wandsworth Council Officials at 21 Wye Street, London**

Please provide the record of individuals with their full names who have access to 21 Wye Street, London, SW11 2SN and their relationship to Wandsworth Council executive officials What is more Wandsworth Borough Executives Mark Maidment, Paul Guilliotti, Christopher Martin, Jon Evans, Andy Algar acted unconscionably too and failed to respond and provide full disclosure to my Constructive Notice and Request dated 14.10.2017 and Pre-Action Protocol Notice dated 20.11.2017"

All you appear to have done is repeat the request and stated full disclosure has not been provided.


This is insufficient for me to carry out a review. You will need to be specific as to which questions have not been adequately answered and why.
