Your request for information has now been considered and the Council's response to your questions is shown below.

You asked:

The number of qualified social workers supplied through recruitment agencies, analysed by Children and Adult services, in January 2012 to date

ANSWER:

In ASC&S we have had 19 Social Workers across all Care Management services

Information on the number of in-house residential units, day care centres and supported living settings, currently using agency care/support workers, their locations, also analysed by Children's and Adult services

We currently have 8 residential unit and 1 residential intermediate care unit run by the Council. These are primarily staffed by staff employed by the local authority, but are supplemented by agency staff for short term and some longer term vacancies.

Day Care centres are covered by Day Opportunities as follows:

Learning Disability Day Services, Office Base, Layton House, Frewin Street (this covers a number of services including Access All Areas and Community Opportunities teams)

Hastings Road Resource Centre, Hastings Road.

These are primarily staffed by staff employed by the local authority, but are supplemented by agency staff for short term and some longer term vacancies.

Which of questions 2 are expected to close during 2012

The residential homes have been through a period of statutory consultation in 2010 and again in 2012 to review their future. Options are being considered by lead elected members but no decisions have yet been made. There are no homes anticipated to close in 2012.

The Executive has taken no decisions on the future of in house day services.

Please see attached. More junior staff names have been removed. We are withholding that information since we consider that to be an absolute exemption under section 40(2) (personal data), and this therefore constitutes a refusal under section 17 of the Freedom of information Act 2000.

The number of Form F assessments that have been completed since January 2012 to date, what number were done by the authority and what number went out to external providers

We are unsure as to what a Form F Assessment is, and it could be that we know this process as something else.
