Fiona,

The fly tipping incident was a one off occurrence that will not be repeated.

We have been at the tunnel for over 18 months without pollution incidents, the individual involved acted without our knowledge and has since resigned.

Because the waste was his own domestic waste and not commercial we feel the issue is no connection to ourselves.

The events are known company wide and have been discussed at Director level, I can assure you the issue will not be repeated.

On a different note, we don't believe that M. Sunde land has a lease on the approach cutting from the end of our road to the water fall on the left hand side of the cutting.

This was leased to Wendy, one of the residents, in 2014 and she has a lease until 2024.

She has kindly provided us with a copy, see attached. Funny enough Wendy phoned us today to say that Mr. Bickel had been in touch to see if she had allowed us to fence off the approach.

This is good news to us!!!
