## Freedom of Information Request - RFI20211103

Thank you for your request to the BBC of 04 July 2021 seeking the following information under the Freedom of Information Act 2000 ('the Act'):

I did not notice myself but I see that the BBC has decided to change the font and spacing used with the BBC branding "blocks", as described here:

Under the transparency afforded me by the Freedom of Information Act please provide by return the total cost of this re-branding exercise.

In accordance with section I(I) of the Act, the BBC confirms that we do hold the total cost within the scope of your request. However we consider this information to be exempt from disclosure under section 43(2) of the Act as disclosure would be likely to prejudice the commercial interests of the BBC and the agencies from whom we buy our goods and services, as revealing market sensitive information of potential usefulness to competitors which could weaken those agencies' position in a competitive environment. In turn this could be harmful to the agencies' business reputation and/or the confidence that customers, suppliers or investors may have in them.

In addition, revealing this information may also weaken the BBC's bargaining position with suppliers of other goods and services, and harm the ability of the BBC to obtain goods and services in the future

As section 43 is a qualified exemption, the BBC is required by section 2(2) of the Act to consider the public interest factors both for and against disclosing information in relation to this request. Specifically, we looked at whether in all the circumstances, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.

Factors in favour of disclosing this information:

- that the BBC's commercial activities (including the procurement process) are conducted in an open and honest way
- that there is transparency in the accountability of the BBC for public funds
- that the BBC is using public money effectively, and that the BBC is getting value for money when purchasing goods and services

Factors for withholding disclosure of this information:

- That companies, or individuals provide the BBC with commercially sensitive information, so that the BBC is able to make robust decisions regarding its suppliers of goods and services, including ensuring that the BBC obtains the best value for money from each transaction;
- That the BBC maintains a strong bargaining position vis-à-vis suppliers during contractual negotiations in order to ensure that the licence fee is spent effectively;
- That the competitive position of companies in their particular market is not disadvantaged by doing business with the BBC. It would not be in the public interest to disclose sensitive information about a particular company if that information would be likely to be used by competitors to gain a competitive advantage.

We are therefore satisfied, in terms of section 2 of the Act, that in all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.

## **Appeal Rights**

If you are not satisfied that we have complied with the Act in responding to your request, you have the right to an internal review by a BBC senior manager or legal adviser. Please contact us at the address above, explaining what you would like us to review and including your reference number. A request for an internal review must be made within 40 working days of receiving the BBC's response to your original request.
