Dear Prime Minister's Office,

I am having to re submit my original FOI request after the original was breached by the Office of prime Minister in it's time allowance , and then once I had notified you of this I was then sent a reply stating my original had been allegedly lost and it would need re-submitting. Therefore I am now making an official request under the Freedom of Information for the following...

Formal Request under the Freedom of Information

Dear Prime Minister's Office,
