Decision:

After carefully considering your request for information on Designated Premises Supervisors Names, the Council has decided that to respond to your request would exceed the appropriate limit as defined in the Freedom of Information Act 2000

Basis for decision:

Section 12 (1) of the Freedom of Information Act allows for a request for information to be refused where the cost of supplying this information exceeds the appropriate limit. This is

called an "exemption". The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 section 3 (3) determines the appropriate limit for local government to be £450.

Why does the exemption apply in this case?:

In order to determine the Designated Premises Supervisors Name, a total of 452 files will need to be reviewed.

We estimate that each file will require a 4 minute investigation per file. As details of 452 files require review in order to determine this information this would result in a total time of approximately 30 hours and is therefore classed as excessive.
