**Re: Freedom of Information Act 2000**

Thank you for your email of 18 August 2020 in which you requested from the Insolvency Service: Details of public sector resourcing suppliers and contracts.

Your request has been dealt with under the Freedom of Information Act 2000 (FOIA).

I can confirm the agency holds some of the information that you have requested and have provided answers to your questions below.

Please note FOIA only applies to recorded information, it does not require public authorities to answer a question unless recorded information exists. Therefore, to answer a request FOIA does not oblige a public authority to create information if the requested information is not held.
