For organisational context: Plymouth Hospitals NHS Trust is the largest teaching hospital trust in the South West. We employ over 6,000 staff working in 350 different roles within the Trust. We offer a full range of general hospital services to around 450,000 people in Plymouth, North and East Cornwall and South and West Devon. These include emergency and trauma services, maternity services, paediatrics and a full range of diagnostic, medical and surgical sub-specialties.

We work within a network of other hospitals to offer a range of specialist services to a population of between 700,000 and two million depending on the type of care needed.

Please provide the following data split by gender and year for each type of referral listed.

Reply introduction

PHNT - Referrals and Outpatient Attendances - Jan 1st 2000 to Nov 30th 2015* due to real time recording.

Please note that as the referrals figures include all referrals irrespective of whether they are consultant or non-consultant led, internal, self-referrals, etc.

Likewise, with the outpatient attendances – this includes everyone irrespective of whether the clinic they attended was consultant led / nurse led or whether the appointment was new or a follow up.

We have for question 4 stated that some data was incomplete. This reflects the fact that in the years specified it was not a requirement to record it and the data held included other criteria. This means any figures held are unreliable for reporting.
