# SPECIFIC DESIGNATION FOR STUDENT SUPPORT IN HIGHER EDUCATION: BIMM Limited

This Guidance will be reviewed on a regular basis and is subject to change and refinement.

Please note that if you wish to offer the courses in Schedule 1 below at other locations these must be designated separately and you will need to apply for specific course designation in an appropriate application window.

Before writing to you to grant the designation of courses listed in Schedule 1 you must first confirm that you have appointed an accountable officer to deal with all matters relating to designated courses. The accountable officer will be either the Principal or Chief Executive Officer or hold a position of equivalent status within the organisation.

The accountable officer is responsible for ensuring compliance with the terms and conditions of specific course designation (as set out in the Department's guidance), which from 2014/15 will include compliance in relation to Student Number Controls.

Please note that any specific course designations granted by the Secretary of State only apply to eligible students who meet the residence criteria for England. If you

Dear

We have been notified by the Department for Business, Innovation and Skills that they have written to you confirming the courses which have been specifically designated for your organisation.

As your courses have now been successfully designated for 2013/14 we will be included them on the HEFCE register of courses with specific designation. This is intended be online in February 2014 – we will contact you with details when it is launched. If current or future students which to confirm designation of a course they can contact coursedesignation@hefce.ac.uk.

Specific course designation will roll forward subject to successful completion of the annual monitoring requirements (which HEFCE will publish guidance on in due course).

If you wish to apply for new courses in the future you will only need to undertake the course eligibility process (i.e. not the financial sustainability, management and governance checks). The final window for applications for new courses starting in 2014/15 opens on 3rd February 2014. The windows for applications for new courses in 2015/16 will open in September 2014 and February 2015 – guidance on how to apply will be published in advance of these windows.

The Student Loan Company (SLC) has been informed of the courses which have received specific designation. As Accountable Officer for your organisation you will be contacted by the SLC's HEI Data Team by email within 5 working days. You will be requested to log onto the SLC HE portal and update the term dates and course fee information of your newly designated courses. This email will include confirmation of the courses that should be updating along with specific guidance on entering term dates. If you have any queries on how to complete this information you should contact the SLC (the relevant details will be included in the email).
