Dear Sir/Madam

I am writing to you on behalf of Elkesley Parish Council and the village that it represents. We understand that you wish to remove the only phone box in the village, you have stated that there were only 47 calls made in 2016 from this box. It is our opinion that a number of people have relied on this facility and it could be that for some people it is their only method of communication.
