Thank you for your Freedom of Information (FoI) request received on 21 January. You asked:

Please could you send me the report mentioned in this article (
https://kittysjones.wordpress.com/2019/01/17/leaked-document-reveals-how-government-aremicromanaging-public-perceptions-of-governments-austerity-programme/) about managing
public perceptions of the government's austerity programme by Laura de Moliere, the
Department for Work and Pension's lead behavioural scientist, and Catherine Hunt, Head of
Insight and Evaluation at the Cabinet Office.

DWP Response:

I confirm that the Department holds the information you have requested but it is being withheld because it falls into the exemption at Section 36 (2) (b)(i) and (b)(ii) of the Freedom of Information Act which states

- "(2) Information to which this section applies is exempt information if, in the reasonable opinion of a qualified person [in this context, a Minister of the Crown], disclosure of the information under this Act
 - (b) would, or would be likely to, inhibit—
 - (i) the free and frank provision of advice, or
 - (ii) the free and frank exchange of views for the purposes of deliberation,"

This exemption requires the public interest for and against disclosure to be assessed.

We recognise that the publication of the information requested could provide a greater understanding of how the government develops and shapes its communication strategies.

However, we have to balance this against the fact that the withheld documentation includes details of a sensitive nature whose publication would be likely to inhibit candour and be likely to prejudice the effective conduct of public affairs.

There is a strong public interest in understanding how government develops and shapes its communication strategies.

There is also a strong public interest in senior communicators in the civil service being able to seek honest advice on the significant and challenging issues facing their profession, including unrestrained and candid contributions from business areas.

On balance, DWP is satisfied that the public interest in maintaining the exemption outweighs the public interest in disclosure.
