# **Accident/Major Incidents**

**Notes:** The Council/Emergency Planning 'Department must be notified of occurrences such as:

- 1. Fluvial flooding surface runoff related flooding
- 2. Transport related incidents
- 3. Severe or prolonged gas/electricity/water failure
- 4. Chemical, Biological, Radiological or Nuclear (CBRN) disasters
- 5. Any major incident that may pose a threat to life or property

**Action:** Take name and telephone number of caller and full particulars of the occurrence (e.g. when; where; what etc) - advise caller that an Emergency Officer will be notified immediately.

1. In the event of flooding the council no longer supplies sandbags.

If you require sandbags in an emergency please contact your Parish Council for possible assistance. Makeshift sandbags can be made from black sacks, plastic bags or pillow cases filled with earth or sand and laid end to end. This will help to divert water.

If the flood is so severe that you are in immediate danger please call the emergency services.

2. Transport related incidents:-

The caller if involved/witness should be advised to call 999 for immediate assistance. Please take as many details regarding the incident as possible, (where, who, what, location, and if any structures are involved and as a result possibly dangerous if so refer to 'Dangerous structures/building control please inform Emergency planning Officer also.

- 3. Prolonged loss of gas/electric/water supply should be referred in the first instance to the relevant utility service, however if as a result of an incident/accident please inform the Emergency Planning Officer and request the caller notify 999 if not already done so.
- 4. CBRN would normally be notified by a member of the emergency services or via the Essex Duty officer, however if a caller reports unidentified gas, vapour or liquid from either an identified or unidentified source, please advise the Emergency Planning Officer and advise the caller to contact 999 immediately and where possible if incident is outside, go in and shut windows and doors and await assistance.

# **Drug Debris Collection**

Discarded needles/syringes pose a significant risk to the public and Council contractors. There is obvious concern about the risk of HIV/AIDS infection from the needle stick injuries, however of even greater concern is the risk of infection from hepatitis B and C. The organisms that cause both these conditions can live for many weeks in the dried blood on discarded needles.

The Uttlesford District Council area currently is implementing a scheme for the reduction of the health risks posed by needles and syringes found in public places and domestic refuse.

#### Purpose of the proposed Needle/Syringe Safe Disposal Scheme

To reduce the health risks posed to both drug users and the general public, resultant from needles and syringes being found in public places and a reduction of the distress this causes.

#### **The Scheme**

The service provided by the Council is the first point of referral for reports of discarded needles/syringes in the District. Calls received by the Council's switchboard will be referred to extension 546. A local trained collector will be contacted, visit the site and collect the item(s). The Community Development Officer (Drugs) will dispose of the sharps box and issue a new kit to the local collector.

With hard to reach debris, the Community Development Officer (Drugs) would undertake the collection using specialist equipment.


