I have just spoken to Chris Grace, who has received up to 15 objections so far to my planning application.


As the planning system is down, he cannot advise whether these are all Formula E, but that is what we expect based on the earlier objections.

At this point in time Chris is concerned that keeping FE on our planning application might jeopardise our application going forward. He has received an FOI request in relation to FE. We may need to drop the FE element of the application, or risk having no planning application in place for the Battersea Evolution structure to commence its build on 15 August.

Please could you advise how you wish to proceed. My advice would be to drop the FE element of the application and make an individual 2 year application for FE after the event.
