Request

- b) A list of all changes to the proposals for speed limit reductions in the area covered by the consultation that were made as a consequence of the consultation (i.e. the difference between the proposals being consulted on in the above-mentioned consultation, and the newer set of proposals being consulted on in the "20mph Area B2 - Traffic Regulation Order" public consultation, referred to online at <<https://www.birminghambeheard.org.uk/economy/20mph-area-b2-tro/>>).
