Freedom of Information Act 2000 - Information Request

Thank you for your request for information under the Freedom of Information Act which was received on 13 December 2018. I can confirm that we hold part of the information you have requested. You asked the following questions, reproduced in **bold** below:

I am requesting the information regarding risk assessment for ambulance staff and the wearing of PPE in particular protective vest.

NEAS does not have a risk assessment that requires the wearing of body armour as it is not a control measure we consider for our operational front line crews. However, our Hazardous Area Response Team (HART) wear ballistic PPE only when involved in Marauding Terrorist Firearms Attack incidents.

I would also like the statistics relating to injuries received as a result of assaults on ambulance staff for 2018. Please categorise into groups:-

- Physical assault
- Blunt force trauma
- Knife
