I am writing regarding your request for information, which was received on 26 July 2016 about the organisational structure chart for CAMHS.

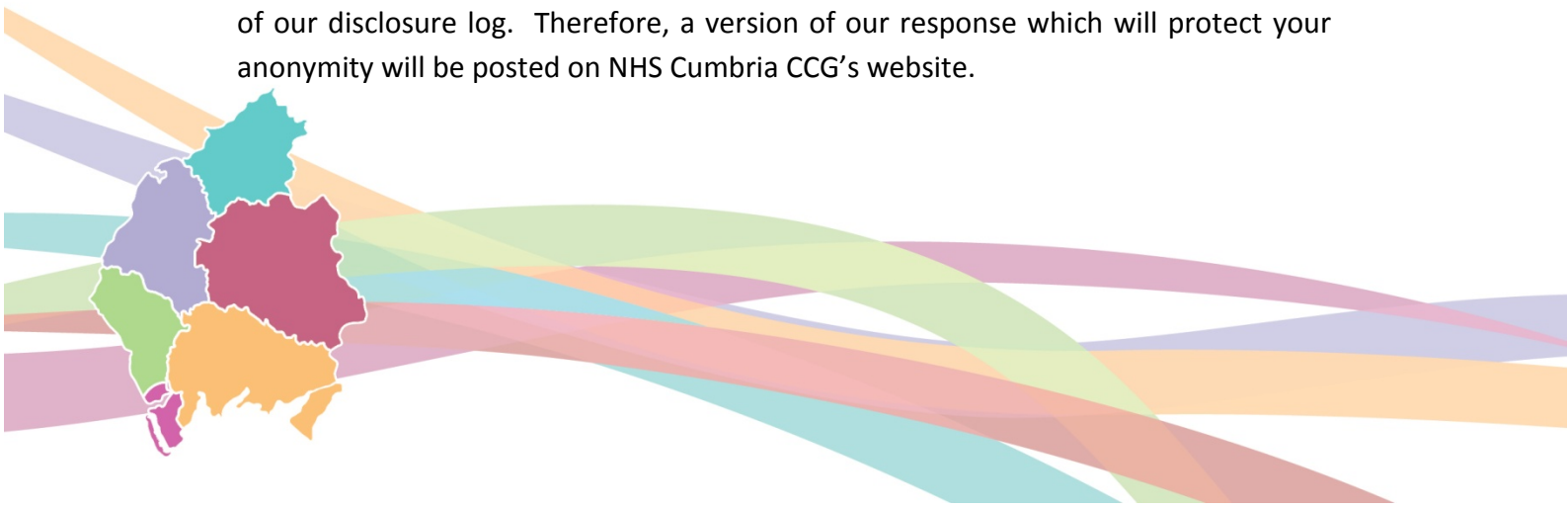
Please provide me with an up to date organisational structure chart for CAMHS including all manager names, contact details & Job titles.


