Dear Councillor Olnier and Councillor Brain

I have received a request from the Rokeby residents to speak at next week's meeting of the Regulatory Committee. I have replied that this is not possible as per the standing orders but they are questioning this.

The starting point is that the public speaking scheme expressly confines public speaking at the Regulatory Committee to planning applications. That is not accidental and the scheme has been confirmed by Council and adopted as a Standing Order in the Constitution (May 2017). However, as you know the chair has a general discretion to allow the committee to hear from members of the public even where there is no right to do so under the Public Speaking Scheme.

There has been a six day public inquiry (including two evening sessions) at which all interested persons have been able to be heard and the Inspector's report gives a fulsome account of the evidence. Legal submissions can be made in writing (and are best made in writing); it would be inappropriate for the Committee to embark on a fact-finding inquiry of its own; and the Committee will not be asked to make policy judgments. In these circumstances, it is difficult to see what public speaking could add to the fairness of the process and it would run the risk of irrelevant, inaccurate, prejudicial or previously undisclosed material being introduced.

I would be grateful to have your views on the approaches we have had from the residents.
