to be made full, entire and due allowance and clear discharge to the aforesaid Mayor, Jurats and Commonalty of the town aforesaid of and from all manner of such like corrodys, rents, arrearages, fees, annuities and sums of money and charges whatsoever issuing from or to be paid from the premises as aforesaid or thereupon charged or to be charged,

AND THESE our Letters Patent or the involments of the same shall be from time to time a sufficient warrant and discharge to the said Treasurer, Chancellor and Barons of our Exchequer and of our heirs and successors for the time being in that behalf,

PROVIDED ALWAYS that if the aforesaid lands and hereditaments called the Stone Beache in Hastinge aforesaid, and also the aforesaid messuages, houses, edifices and buildings erected, set up and built on the aforesaid parcel of lands called the Stone Beache, and the aforesaid lands and other the premises called the Cliffelandes, and the aforesaid tenements and other the premises called Magdalens and Churchelandes, and the aforesaid Fresh and Salt Marshes in Hastings aforesaid, and all the lands, tenements and other the premises formerly given or appointed as aforesaid by the aforesaid Jenetta a Clyve otherwise Clyffe, or some other person or persons for the maintenance of an Obit in the Churches of All Saints and Westham or in one of them, and the aforesaid lands, tenements and hereditaments given, assigned or appointed as aforesaid for the aforesaid Obit and Sherpes Obit or the rents and profits of the same the first day of May in the twenty-fifth year of our reign and before concealed, withdrawn and detained from us and so unjustly concealed, withdrawn and detained, have remained until the twenty-sixth day of June in the twentysixth year of our reign, That then these our Letters Patent as to such a parcel of the same premises called the Stone Beache and also the aforesaid premises erected or built upon the Stone Beache and the premises called the Cliffelandes and the aforesaid premises called Magdalen and Churchelandes and the aforesaid Fresh and Salt Marshes in Hastinge aforesaid before granted by these Presents, and as to such a parcel of the premises heretofore as aforesaid given, appointed or limited for the maintenance of the said Obits in the aforesaid Churches of Hastinge and Westham by the aforesaid Jenetta a Clyve or any other person beside the aforesaid Knightes Obit and Sharpes Obit which, or the rents and profits of which, are not so from us concealed, withdrawn or unjustly detained, shall be void and of no effect in law, And for the rest nevertheless shall stand and be of good and sufficient in law, any thing in these present Letters Patent to the contrary thereof notwithstanding,

MOREOVER WE WILL and by these Presents do grant to the aforesaid Mayor, Jurats and Commonalty of the town and port of Hastinge aforesaid that they may and shall have these our Letters Patent under our Great Seal of England, in due manner made and sealed without yielding, paying or making any fine or fee, great or small, to us in our Hanaper or elsewhere any way to our use, by reason that express mention is not made in these Presents of the true yearly value or of any other value or certainty of the premises or of any of them or of any other gifts or grants by us
