- AND THAT the same person so chosen and every person so to be chosen into the office of Mayor shall take a corporal oath before the Jurats of the same town and port then present for the faithful execution of the said office of Mayor in manner and form aforesaid,
- AND WE FURTHER will and by these Presents for us, our heirs and successors, do grant to the aforesaid Mayor, Jurats and Commonalty of the town and port aforesaid and their successors that the Mayor for the time being, and his successors for the future for ever, shall and may have such and the like privileges, liberties and authority in, concerning or touching the election, refusing or removing the Jurats of the town and port aforesaid for the time being and their successors or any of them, which the Bailiff of the town and port aforesaid for the time being and their successors before the making of these Presents had or might have had,
- AND WE FURTHER WILL AND GRANT for us, our heirs and successors, that as often and whensoever it shall happen that any one or more of the said Jurats or their successors shall die or dwell outside of the town and port aforesaid or be duly turned out for any just cause from his said office of Jurat or voluntarily withdraw from his said office or refuse to exercise that office, that then and so often it shall be lawful for the Mayor and other Jurats of the town and port aforesaid then surviving or remaining, or the greater part of them (of whom we will the Mayor for the time being be one) or the greater part of the Commonalty to choose, nominate and prefer to and unto the place of him or them, the Jurat or Jurats so happening to die or be removed, And that he or they so chosen, having first taken a corporal oath before the Mayor of the town and port aforesaid for the time being, or his sufficient deputy, and the Jurats there present, shall be of the number of Jurats of the town and port aforesaid, And this as often as the case shall happen,
- AND ALSO OF OUR FURTHER GRACE We will and by these Presents of our certain knowledge and meer motion for us, our heirs and successors do grant to the aforesaid Mayor, Jurats and Commonalty and their successors That it shall and may be lawful for the aforesaid Mayor and Jurats and their successors that they may and shall have full power and authority to and that they lawfully may by themselves, or by the greater part of them (of whom we will the Mayor for the time being be one) to turn out of his or their office or offices of the aforesaid Jurat of the town and port aforesaid any one or more of the said Jurats for the time being, for any reasonable or just cause, reasons or considerations whatsoever appearing or that shall appear expedient, reasonable and fit for them or the greater part of them (of whom we will the Mayor for the time being be one) and to choose, nominate and prefer any one or more of the Freemen of the town and port aforesaid for the time being into or to the place or places of such Jurat or Jurats, in such manner and form as the Bailiff and Jurats of the town and port aforesaid for the time being before the making of these Presents by the liberties and customs of the town and port aforesaid have used, might or ought to turn out, choose, nominate and appoint,
