**REQUEST FOR INFORMATION/FREEDOM OF INFORMATION ACT 2000**

We refer to your email, received at our office on 19 March 2010, requesting the following information:

*"Can you please give me a full 6 year breakdown of all monies paid to companies in the royal docks and/or on behalf on companies in royal docks."*

Clarification of the request was sought, by email, on 30 March 2010 and on 07 April 2010 we received the following clarification:

*"The Royal Docks area I am talking about is the "electorally" know area Royal Docks. I am happy for you just to provide detail of companies who are on or use LDA owned land in this area."*

**Duty to Confirm or Deny**

We confirm that we do hold information of the description specified in your request.

**Information Held**

Please note that we have interpreted the definition of the area provided in your clarification email, "the "electorally" know area Royal Docks", as referring to the Royal Docks Ward and also note that you have amended your request and now only require "detail of companies who are on or use LDA owned land in this area". Although we don't hold the 'Map of the London Borough of Newham (Electoral Changes) Order 2000' which seems to be required to identify the Royal Docks Ward, we have been able to use the Royal Docks Ward map available on the Metropolitan Police web site (<http://maps.met.police.uk/access.php?area=00BBGT&sort=area>) to identify companies within this area that are tenants or licensees of the LDA. Please note however, that the LDA does not own the whole area outlined on this map.

We have identified 20 companies or organisations falling within the scope of your request as outlined above.
