# **Your Request**

Thank you for your request for information under the Act which we received on 04 November 2019. You have requested the following information:

- A. List of all publicly-owned assets sold by Perth College UHI in the previous 5 years, detailing sale price, buyer and date of sale;
- B. List of all assets currently owned by Perth College UHI

### **Our Response**

With regard to your request for information, we respond as follows

- A. The attached spreadsheet (tab 1) shows that Perth College UHI sold 1 asset during this time period, namely a flat in Morris Court, Crieff Road, Perth. Please be aware that, as this was a private sale undertaken by an Estate Agent, we are unable to provide details of the buyer.
- B. The attached spreadsheet (tab 2) lists the land and building assets currently owned by Perth College UHI, provided in the same format as above.

In both responses, layout and terminology has been matched as closely as possible to that requested.

Your request should:

a describe the nature of your original request; and b explain the reasons why you are not satisfied with our response

If you remain dissatisfied with how your request for information has been dealt with you also have the right to apply to the Scottish Information Commissioner for a decision as to whether we have handled your request properly.
