Thank you for your request for information, which was received on 17 March 2021.

Please find our response below.

## Request details:

I would like to make a request under the freedom of information act to obtain information regarding school cluster groups and/or federations of schools within the local authority. I would like the following information please:

Number of clusters and or federations in the authority. Which schools are in each cluster / federation

The name of the cluster or federation lead / chairperson and the name of the school in which they work.

## Service response:

We have considered your request for information. Following a search of our paper and electronic records, I have established that the information you requested is not held by Surrey County Council.

Under section 21 of the Freedom of Information Act (FoIA), we deem the information requested to be reasonably accessible to you because it is in the public domain. This response, therefore, acts as a refusal notice under section 17 of the FoIA.

Please note that we interpret the terms "Cluster" and "Federation" as being two separate entities within the scope of this information request. We deem a "Cluster" to be the informal grouping of schools for, e.g., mutual administrative and economic benefit; whereas a "Federation" is a group of schools formally linked under one governing body.

"There are a range of different terms used to describe inter-school collaborative activity in practice and in the literature. Terms such as 'partnership', 'network', 'cluster', 'family', 'federation', 'engagement' and 'collaboration' are used interchangeably to describe different ways of schools working with one another making an already complex area even more difficult to discern and trying to identify evidence relating to inter-school collaboration challenging..."
