Thank you for your request, received by NHS Leicestershire County and Rutland and NHS Leicester City on 23 October 2012, for information under the Freedom of Information Act 2000. Response from NHS Leicestershire County and Rutland (NHSLCR) and NHS Leicester City (NHSLC):

Please note: Any responses provided within this FOI should cover the time period from the initiation of the national HPV vaccination scheme to present.

Q1: Do all girls aged 12 -13 get offered the HPV vaccine at school?

Response to Q1: NHS LC and NHS LCR confirm that girls aged 12-13 years do get offered the HPV vaccine in school.

Q2:

2a) for girls accepting, do their GPs get notified of their vaccination?

Response to Q2: NHS LC and NHS LCR can confirm that for girls accepting the HPV vaccine in the school GPs are then notified of their vaccination.

2b) for girls offered but not accepting the vaccine, do their GPs get notified of their non-vaccination?

Response to Q2b: No, for the girls offered but not accepting the vaccine, GPs are not actively notified but GPs can check patient records via Systm1.
