ENVIRONMENTAL INFORMATION REGULATIONS 2004 – INFORMATION REQUEST (FOI_10-167; EIR_11-012)

Your request for information received on 25 July 2011 as clarified on 11 August 2011 regarding information held by our institution as a result of the participation of our employees in the Second Lead Authors Meeting (LA2), 18-22 July 2011, at Brest, France has now been considered and some of the information requested is enclosed herewith. Please accept my apologies for the delay in forwarding this response to you.

For your convenience, we have reproduced your request in the attachment to this letter and provided our response in line with each question. Given the large amount of information involved, we have itemised the relevant material and provided a response for each document. For each document, there may be a variety of responses ranging from release of a document to citation of a webpage to the invocation of an exception. We trust this will be to your satisfaction.

In line with your email of 11 August 2011, we have removed material relating to travel arrangements, expenses and general logistics relating to the meeting from the scope of the request and have focussed on material dealing with the assessment process itself.

However, it is not possible to satisfy all elements of your request directly, and, in accordance with Regulation 14 of the Environmental Information Regulations 2004 this letter acts as a partial Refusal Notice. We are not obliged to supply this information and the reasons for exemption are as stated below:

Release of the requested information, would have an adverse effect on the persons providing the information

Exception explanation

There is a significant amount of information that was provided by the IPCC WG1 TSU to two of our employees as a result of their participation in the meeting in Brest which is available to yourself via other means, specifically via the websites of both the IPCC WG1 and the IPCC Secretariat. Where this is the case, we have so indicated in the list of relevant material.

With regard to our use of Regulation 13(1), we would hold that, firstly, the some of the requested information contains information that meets the definition of 'personal information' as defined by section 1(1) of the UK Data Protection Act 1998 (DPA). It is our belief that disclosure of this information would be contrary, at the very least, to the first data protection principle under the DPA; namely that information be processed in a fair and lawful fashion that also meets at least one of the conditions set out in Schedule 2 of the Act. We do not have consent for the release of this information, nor are there any conditions present that would allow us to release under any of the other provisions of Schedule 2 of the DPA. This applies, in particular, to the correspondence between Dr. Osborn and his co-authors who have not given their consent for release of their personal information.

We invoke Regulations 12(4)(d) in several instances where the information provided to, or exchanged by, our two participants consists of material in the course of completion or are unfinished documents. In particular, the material relating to the 'Zero Order Draft', is incomplete and/or an unfinished draft of a much larger work to be published in future; namely, the AR5 report itself.

In regards the correspondence and attachments to such correspondence, some of it quotes material that is within the Zero Order draft. Even where there is no direct quotation, the correspondence and emails certainly 'relate to' material in the course of completion or unfinished documents as the exchange of ideas is, in effect, the process of drafting the Zero Order draft. The emails themselves are the means by which the incomplete material comes into being, so the content of the emails themselves are also incomplete material (or assuredly relate to incomplete material).

Turning to Regulation 12(5)(a), we base this on representations received from the IPCC WG1 TSU itself in which it objected to the release of some of the requested information. Clearly the IPCC WG1 TSU is an international body as defined by the EIR and a number of UK-based academics are involved in the IPCC process. Release of some information in the face of the objections and representations provided to us by the IPCC WG1 TSU would, we believe, damage the ability of UK-based academics to fully participate in this significant global initiative. Indeed, the IPCC has published guidelines, available on the web, that explicitly provide for, and demand, confidentiality of some information and have been agreed to by many national governments. To release information intended to be confidential would have a significant negative impact on relations with the IPCC generally, not just for UEA-based academics, but for all UK-based academics as well, and would also fly in the face of the agreement between the member governments.

In regards the correspondence of Dr. Osborn the correspondents with which he communicated have indicated their lack of consent for the release of this information. Where we to release such information, it is clear that the willingness of academics within other nations to correspond openly with UK academics would be diminished and the interests of the UK thereby harmed.

Regulation 12(5)(f) is cited on the basis that the IPCC WG1 TSU has made representations to our institution regarding the release of some the requested information, claiming that the release of the information would adversely affect their interests. They have provided reasons for their position, and where cited, we have accepted those reasons and explanations as justifiable. To release such information would significantly damage the reputation of the IPCC and its ability to work with academics from all nations.

In regards the correspondence of Dr. Osborn, the correspondents with which he communicated have indicated their lack of consent for the release of this information. Such lack of consent is evidence of the perception of an adverse effect on the interests of the person providing the communication and we have therefore excepted this information.

Public interest

Pursuant to Regulation 12(1)(b), we must also apply a public interest test to any and all information excepted under Regulation 12 and this test must be applied as a whole to the entire request rather than exception by exception. It is our opinion that, in relation to the excepted material, the public interest lies in non-disclosure.

Where draft versions of material in the public domain have been requested, there is little public interest in the disclosure of earlier, unapproved versions of the same material. There is also a public interest in ensuring that the information available to the public has been properly reviewed and assessed as takes place in the academic publication process. This lessens the possibility that earlier, less well-examined versions of the information are released that do not, in fact, represent the fully considered views of the authors and/or contributors. Additionally, release of early drafts and preliminary information could inhibit the free and frank exchange of views required to produce such work.

With specific reference to the material covered by this request, we certainly acknowledge the public interest in the work of the IPCC. However the IPCC will, in 2013, publish a final version of the AR5 report and a substantial amount of interim material will be released concurrent with the publication of the final report. We feel that the publication of both the interim material and final report will meet the public interest in knowing of the development of, and end product of, the work of the IPCC, and that there is little to be added to the public understanding of, or participation in, the IPCC process by the publication of very preliminary information.

Additionally, the IPCC will be inviting concerned individuals to become external expert reviewers of the First Order Draft (FOD) which will provide an opportunity for the wider community to review and comment upon a draft of the work in progress.

In relation to material excepted by virtue of the adverse affect on the persons providing the information, in this case the IPCC, there is a public interest in preserving the ongoing good relationship between the UK academic sector and the IPCC in that it is to the public benefit that UK-based academics participate in fully such a global initiative of value. There is also value to the greater non-UK public in the full participation and contribution of UK-based academics in the IPCC assessment process.

Additionally, there is a public interest in preserving some private space within which academics can communicate freely and openly, exchange frank and robust views and work towards an agreed consensus that will be reflected in the published output of the IPCC process. This also allows for the development of material without the pressure of external and public discussion of every exchange in the drafting process.

The IPCC, in various public announcements, and in conversation with the participants within the IPCC process, has made assurances to participants regarding the confidentiality of certain work and communication. It would not be in the public interest to act contrary to these assurances and thereby reduce not only the reputation of the

IPCC, but also the ability of the organisation to attract, and work with, noted academics from around the world.

I would also add that any material released over which UEA has copyright is released subject to the understanding that you will comply with all relevant copyright rules regarding reproduction and/or transmission of the information released.
