## WEST SUSSEX COUNTY COUNCIL (WORTHING: VARIOUS ROADS) (WORTHING HALF MARATHON) (TEMPORARY TRAFFIC REGULATION) ORDER 2018

**WEST SUSSEX COUNTY COUNCIL**, acting as the local traffic authority and in exercise of its powers under sections 16(a) and 16 (b) of the Road Traffic Regulation Act 1984 as amended, and all other enabling powers hereby makes the following order:

- 1. This Order shall come into operation on 11 February 2018 and may be cited as the West Sussex County Council (Worthing: Various Roads) (Worthing Half Marathon) (Temporary Traffic Regulation) Order 2018.
- 2. Due to a special event being held on or near roads, traffic on the roads listed in the First Schedule to this Order should be restricted.
- 3. No person shall cause or permit any vehicle to be driven on the lengths of roads specified in the First Schedule to this Order.
- 4. During the operative period of this Order the Second Schedule of the West Sussex County Council (Worthing: Union Place) (One Way Traffic) And (Various Roads Consolidation) Order 2010 is hereby suspended insofar as it refers to New Street and Prospect Place.
- 5. Nothing in Article 3 shall apply to a vehicle being used by the police, fire service, Ambulance Service of St John's Ambulance Service in connection with an emergency or in connection with the safe running of the Worthing Half Marathon, or a vehicle being used by the event organiser in connection with running the event.
