

WEST SUSSEX COUNTY COUNCIL
(ALDWICK, BOGNOR REGIS & FELPHAM: BOGNOR PROM 10K RUN)
(TEMPORARY TRAFFIC REGULATION) ORDER 2018

WEST SUSSEX COUNTY COUNCIL, acting as the local traffic authority and in exercise of its powers under sections 16a and 16b of the Road Traffic Regulation Act 1984 and all other enabling powers hereby makes the following order:

1. This Order shall come into operation on 20 May 2018 and may be cited as the West Sussex County Council (Aldwick, Bognor Regis & Felpham: Bognor 10k Run) (Temporary Traffic Regulation) Order 2018.
2. Due to a special event being held on or near roads, traffic on various roads in the parishes of Aldwick, Bognor Regis and Felpham should be restricted.
3. No person shall cause or permit any vehicle to be driven on the length of road specified in the First Schedule to this Order.
4. No person shall cause or permit any vehicle travelling on the length of road specified in column 1 of the Second Schedule, to travel in a direction other than that specified in column 2 of the Second Schedule.
5. Nothing in Articles 3 or 4 shall apply to a vehicle being used in connection with the holding of the Bognor Prom 10k run, or to vehicles proceeding by arrangement with the event organiser.




