

We're planning on putting on our web site the fact that we carried out a protester eviction, draft outline below.

To note, we don't normally mention who our client is and overall focus on the expertise to do the job ensuring we don't take sides in the issues.


On this basis, do you have any objections?

- Full Police support to do the job, 20 plus officers on site and a big well done from them once completed
- Expected 15+ protesters with back up protesters of over 80 just half a mile away
- Present for a number of months however causing high way safety issues (blocking the site line for lorries getting in and out of a site) - causing road closures and regular contraflows disrupting the local's lives
- Eviction was largely peaceful
- Our climbing team also had to manage 2 protesters who were locked on at height in a precarious tower made from pallets.
- In tower, one man was locked on with a rigged noose type contraption around his neck he advised, our climbing officers could see a devise too. This would cause a fatality if not managed in the right way as it had been rigged to do so - after being respectfully asked to come down a number of times, protester was cut out of their holdings and brought to safety
- One protester was assisted out of the area, the rest left peacefully
- Care was taken to ensure that the protesters had every opportunity to remove personal items or possessions - we retrieved a symbolic hand painted Crocodile head for them - keeping reasonable and neutral to their cause assists to officers and Police by keeping the situation as calm as possible
- Possession of the land has now been handed back to the client with ongoing security to reduce the likelihood of them returning





