Just to advise, we appear to be having mixed messages from Cuadrilla regarding the use of their welfare facilities.

I'm waiting for further details and we're attempting to contact Cuadrilla again. However, it seems that different shift managers in Cuadrilla have differing attitudes to the Security Guards using their facilities.

Whilst we hope to be able to resolve this situation between us, I thought I ought to put you on notice that there may be a need for portable facilities to be provided on site. Not a great deal of room but if needs must then that's what we'll have to do.

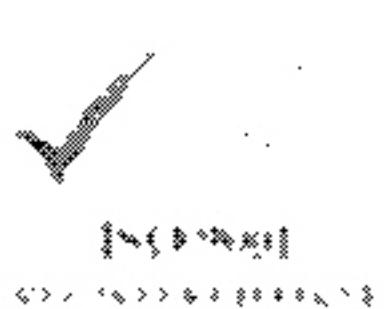
In the event these facilities are required, we previously quoted you:

"portable toilet facility costs are delivery and collection (total), plus per week for the hire."

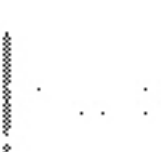
Alternatively, I recall that the Council may have these facilities available which, if provided, would save the Council some money.
