The majority of Semi-Independent placements are made with providers on our Framework. LBS also holds a list of 47 additional providers that may be used on a spot purchase basis as appropriate if suitable placements are not available from the Framework.

This changes throughout the year as our semi-independent placement costs, commissioned via the London Borough of Sutton Framework or spot purchased, are set , reviewed and, where necessary, amended based on the needs of the young person for accommodation and support services at any one time.

- Cost data on services is not coded by 24 hour and non 24 hour units.
- Accommodation and support service cost data for placements are not recorded separately.
