# Section 12: Exceeds the appropriate limit

We are unable to provide the information requested as the information is not collated in a way that would allow us to easily extract the data requested. To locate and extract the information would take considerable time. We consider that this would exceed the appropriate limit, as specified in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004; therefore section 12(1) of the Act applies.

The appropriate limit has been set at £450 and may include working hours of any person acting on our behalf at a rate of £25 per hour. This equates to 18 hours to locate and extract the relevant information.

Not all of this information is held centrally. In order to locate the relevant information we would need to manually review and create information we do not currently hold. We estimate that it would take in excess of 18 hours to identify the information requested.

In accordance with the Freedom of Information Act 2000 this letter acts as a Refusal Notice.
