  - a. Brighton and Hove: Interesting how inspectors relied on data capturing. Also, their organisational leaders had a lot of information about SEND reforms

  - b. Hertfordshire: Information for processes like the EHC assessment process not on the LO. Parents felt that they don't know about the Local Offer. Discharge from Hospital not clear as a process. 9 Delivering Special Provision Localities who are inconsistent on commissioning. Parents were very critical as they felt they can't influence, and the leaders of the organisation were not fully aware of parents dissatisfaction.
  - c. Enfield: They has a SEF in place, thus the LA should know their strengths and weaknesses. Focused on Children Exclusions.
  - d. Nottinghamshire Not enough information from parents or children. Strengths in a lot of areas, but lacking with Preparing for adulthood and identification of needs in schools.

  - a. Need EHC Assessment and Timelines being made aware to parents
  - b. Conversions are not as good quality compared to the new EHC Plans
  - c. Parents are unsure what roles they have when receiving a Draft
  - d. SENCOs feel there is a lot of duplication in the documentation they need to feel in for annual reviews.
