SUBJECT: Senior Officer Selection Criteria

I refer to your email dated 6 April 2014 regarding the above which has been handled in accordance with the Freedom of Information (Scotland) Act 2002 (FOISA). Please accept my apologies for the delay in responding to you.

Articles in the Scottish press today about the selection process for ACCs in PSoS note that there is a list of qualifications that were deemed to be equivalent to the SCC/PNAC accreditations mentioned in the role advertisement and related documentation.

Whilst the individual who is named as being a conduit for this list has now retired from the HMICS I have no doubt that it may be needed in the years ahead for any future CC/DCC/ACC appointments.

Could I please have a copy of the list of courses that are deemed to be equivalent to the PNAC and/or SCC accreditation

(For clarity accreditation means successfully passing said courses)

Could you please give details of the location, duration and syllabus for each course that has been considered as a potential equivalent together with details of those courses that were considered to be equivalent, the date that decision was made and the dates of any reviews of that decision?

Your request for information has now been considered and I can advise you that Police Scotland does not hold the information requested by you. In terms of Section 17 of the Act, this letter represents a formal notice that information is not held.

By way of explanation, the recruitment process for the Senior Management Team (Command Team) was undertaken by the Scottish Police Authority in conjunction with the Scottish Government. Accordingly, the decision on which courses were 'deemed to be equivalent' was not undertaken by Police Scotland, therefore, the Service does not hold the requested information.
