  escalates through to the on call senior manager rota for FYPCLDA and then to
  Director on call rota for the Trust.

## Adult Eating Disorders inpatient unit:

- Out of hours medical cover is provided through the duty doctor system via the Bradgate unit.
- Operational cover is provided through the duty service manager at the unit. This
  escalates through to the on call senior manager rota for FYPCLDA and then to
  Director on call rota for the Trust.

## **CAMHS** Inpatients:

- Out of hours medical cover is provided through the duty doctor system and there is also the on call CAMHs Consultant and Senior Clinician for CAMHs.
- Operational cover is provided through the duty service manager at the ward. This
  escalates through to the on-call senior manager rota for FYPCLDA and then to
  Director on call rota for the Trust.
